

EBID Extract (XML) File Format

Overview

The AGIISEntityExtract.xml document (here after referred to as “the document”) provides an interface file from AGIIS that reports EBID entity change transactions to subscribers. The definitions for the document’s structure can be found in the <https://www.agiis.org/XML/namespace/AGIISSchema.xsd> document. The XML schema definition is described in the document found at <https://www.agiis.org/Links/AGIISSchema/AGIISSchema.html>.

The header structure contains information specific to the document itself. It is used to communicate the unique id, the date and time the document was created, the sender and intended recipient.

The body structure contains a set of nested structures that report entity transaction information. Like the EDI and Excel file formats, entity transactions contain a “before image” and “after image” to indicate what entity attributes changed.

Subscribers can download their documents by using either the File download feature on the AGIIS web site or an FTP client. Subscriber’s wishing to use an FTP client are encouraged to contact the AGIIS help desk prior to downloading their first file to verify their FTP information.

Sample Document

The following is a sample document containing a demographic update transaction. An AGIISEntityExtractDetails element can contain multiple EntityTransaction elements.

EntityInformation Element

The EntityInformation element contains all of the attributes associated with an entity in the AGIIS directory. Any NULL or empty elements indicate that that particular entity attribute does not exist in the directory. For example, if an entity does not have a mailing address, then the MailingAddress element will not appear. In this example, the target entity does not have mailing address or SPLC code, so both the MailingAddress and SPLC elements are omitted. Note that the LastModifiedUserID element is only populated when the subscriber receiving the extract is the same as the subscriber who last updated the entity in question.

EntityTransaction Element

A transaction consists of a maintenance reason code, a transaction date and time, and entity information. Depending on the maintenance reason code, different entity elements will appear. For example, for an Add transaction, only the CurrentEntity element will appear since the PreviousEntity, BoughtByEntity, and ReplaceByEntity elements do not apply.

The maintenance reason codes closely map to existing 838 Maintenance Reason Codes (in the PLA05 segment) and existing ASCII / 996 / Private format change types with a few additions:

Add	Entity was added to subset
Delete	Entity was deleted from subset
Update	Entity had a demographic update
Bought Out	Entity was bought out
Replaced	Entity was replaced by another entity
Out of Business	Entity status changed to out of business

The new XML maintenance reason codes are:

Reactivate	Entity changed from inactive to active
Deactivate	Entity changed from active to inactive
GLNAssignedToReusePool	Inactive entity has had its GLN removed and designated for reuse

The EntityTransaction element contains different elements based on the maintenance reason. A CurrentEntity of type EntityInformation is always included in every EntityTransaction element. The CurrentEntity element contains the entity information at the time of the transaction.

As with the other file formats, an update to a proprietary code will be reflected as a Delete transaction followed by an Add transaction.

The following sample transactions show sample EntityTransaction elements that would exist as an array in the AGIISEntityExtractDetails element.

Update Transaction

An *Update* maintenance reason is used to indicate a demographic change was made to an entity. If the entity status changed with the demographics, the corresponding maintenance reason (Bought Out, Out of Business, or Replaced) would be used to indicate that particular type of change rather than an Update. The **CurrentEntity** element contains the entity attributes after the specified change was made to the directory. The **PreviousEntity** element contains the entity attributes before the specified change was made to the directory.

Bought Out Transaction

A **Bought Out** maintenance reason is used to indicate that an entity was bought by another entity. **CurrentEntity** contains the entity attributes of the entity that was bought out. The **BoughtByEntity** element contains the entity attributes of the buying entity.

A **Replaced** maintenance reason is used to indicate that an entity was replaced by another entity. **CurrentEntity** contains the entity attributes of the entity that was replaced. The **ReplacedByEntity** element contains the entity attributes of the entity that replaced it.

An **Out of Business** maintenance reason is used to indicate that an entity has gone out of business. The **CurrentEntity** element contains the entity attributes after the specified change was made to the directory. The **PreviousEntity** element contains the entity attributes before the specified change was made to the directory.

Reactivate Transaction

A **Reactivate** maintenance reason is used to indicate that an entity has been changed from Inactive to Active. This may have been a result of the entity status changing from Out of Business, Bought out, or Replaced to In Business or the entity may have simply been set to Active from Inactive. The **CurrentEntity** element contains the entity attributes after the specified change was made to the directory. The **PreviousEntity** element contains the entity attributes before the specified change was made to the directory.

Deactivate Transaction

The **CurrentEntity** element contains the entity attributes after the specified change was made to the directory. The **PreviousEntity** element contains the entity attributes before the specified change was made to the directory.

GLNAssignedToReusePool Transaction

A *GLNAssignedToReusePool* maintenance reason is used to indicate that an inactive entity has had its GLN removed and designated for reuse. Note that until the GLN is *actually* reassigned to a new entity, the “old entity” can be reactivated and its original GLN (the one designated for reuse) will be reclaimed and assigned to the original entity. The CurrentEntity element contains the entity attributes after the specified change was made to the directory. The PreviousEntity element contains the entity attributes before the specified change was made to the directory.
